## San Dieguito River Park JPA Message

the long-awaited project south of Via De La Valle and east of Interstate 5.

This lagoon restoration will create a new trail connection from the Dust Devil Nature Trail to the Coast to Crest Trail, enhance and expand riparian habitat along the San Dieguito River, and convert approximately 84 acres of former agricultural fields and other degraded land into tidal wetlands, which are an integral part of biodiversity in our region. In total, 64 acres of tidal salt marsh, 15 acres of brackish wetlands — which are a mixture of saltwater and freshwater — and an additional five acres of riparian habitat will be restored through this project.

The restoration began with the removal of existing nonnative vegetation and accumulated soils that will allow tidal flow and planting of new wetland plant species. The excavated soil will take several months to remove. It will be spread on a nearby slope south of the lagoon

and replanted as coastal sage scrub. The new tidal wetlands and transitional upland habitat will be planted with native plants and maintained in perpetuity.

Project completion is expected in the spring of 2024.

"The restoration of the San Dieguito Lagoon wetlands is a landmark project that will transform the region," said San Diego Council District 1 Councilmember and JPA Board member, Joe LaCava. "I am proud of this collaboration between the City of San Diego, SANDAG, Caltrans, and San Dieguito River Park JPA. Projects that enhance San Diego's unique natural environment while creating long-term sustainable solutions are essential to our community."

## **Conservation: Abundant Del Dios**

One year ago and with tremendous help from donors, we closed escrow on 117 acres overlooking Lake Hodges. Since then, numerous specialists have visited the Del Dios property to take stock of its resources. So far, the surveys show wildlife is thriving and the scrubby slopes are home to an extremely rare bird and plant.

Experts have documented 60 bird species, including the federally-endangered California gnatcatcher, seven species of herpetofauna, and five species of mammals.

As for fauna, the acreage includes 168 plant species, including five considered to be of "special status." Surveyors have identified a healthy population of Encinitas baccharis. Limited in range to San Diego County and a small slice of Riverside County, Encinitas baccharis is considered "endangered" and "threatened" by state and federal authorities, respectively.

The wildlife surveys will inform a management plan for the habitat, which provides an important connection to neighboring wildland areas. The data-gathering also meets the requirements of the federal and state grants that covered much of the \$2.76 million purchase price.

We will never forget the role our awesome donors played in securing this property for conservation. Thanks to their generosity, the Campaign for Del Dios netted \$322,000 in less than three months to completely cover the Conservancy's share of the acquisition.

## **Education: New! Online Learning**

Watershed Explorers, Pollinator's Paradise, Thru the Lens — through the years, we have developed these educational programs to get kids excited about nature. Today, we are excited to have packaged the programs as free, online courses.

The courses are designed to bring outdoor, educational experiences to people who are unable to attend in person. The curriculum aligns with state standards and can be used by teachers in public schools.

Watershed Explorers visit locations from the pine forest to coastal lagoons; Pollinator's Paradise explains why pollinators are important and how we can help them with challenges of climate change they face; Thru the Lens activities analyze camera trap photographs to understand wildlife movement across our region.

In another course, "San Diego Wildlife, Climate Change, and You!" students examine the impacts of a changing climate upon four species of concern within the watershed.

The courses are developed in cooperation with San Diego State University, the Conservation Ecology Lab at SDSU, and Climate Kids, with funding from SDG&E and the Conrad Prebys Foundation.

## **Riverpath Del Mar**

We are proud to partner with the City of Del Mar to advance plans for the Riverpath Del Mar Phase III Extension Project. As planned, the half-mile-long trail would include a combination of decomposed granite walkways, at-grade boardwalks and raised boardwalks. In addition to financial and planning support, the Conservancy has offered the city use of lagoon-fronting property as mitigation to compensate for any environmental impacts the trail might cause. Construction is expected to begin in August 2023 and last about four months. We can't wait for this great, recreational asset to open!
